Official Rules

Promotion Period

Promotion begins on September 1, 2023 at 12:00am Mountain Standard Time ("MST"), and ends on November 30, 2023 at 11:59pm MST (the "Promotion Period").

Entry

By entering the Promotion, each entrant accepts and agrees to be bound by these Official Rules. No purchase or payment necessary to enter. Individuals that open a new Pima Federal Credit Union ("PFCU") CareFREE Plus checking account during the Promotion Period, with minimum aggregate monthly deposits of \$1000 and current enrollment in eStatements at the end of the Promotion Period will be automatically entered into a drawing to win five (5) available prizes. Individuals may also enter by providing name, address, and phone number on a 3x5 card and mailing it to: Pima Federal Credit Union, 6860 North Oracle Road Suite 100, Tucson, Arizona 85704, Attn: Member Acquisition Holiday Giveaway; must be received before the end of the Promotion Period. One entry per person.

Prizes

There will be five (5) winners who will receive a one-time \$1,500 deposit into their CareFREE Plus checking account.

Winners will be selected by random drawing from all eligible entries on or about December 1, 2023 and will be notified on or about December 4, 2023. Members must be in good standing at time of drawing and prize notification. If winner does not have a qualifying Pima Federal Credit Union CareFREE Plus checking account, prize will be awarded upon qualifying for and opening a CareFREE Plus checking account with Pima Federal Credit Union, as long as account is opened on or before December 11, 2023.

Each winner will be notified by telephone and/or electronic mail and must complete all required paperwork and tax forms, and provide a valid U.S. issued unexpired photo identification by December 11, 2023 at 12:00pm MST; otherwise Pima Federal Credit Union will randomly select another winner. Winner is responsible for all applicable federal, state, and local taxes. The prize cannot be substituted, transferred, or exchanged for any other award, amount, cash value, or benefit. Odds of winning depend on the number of entries received.
